

Descendants of Johannes "John" Summers Esq. and Anna Van Deren

This report is meant to give an overview of the descendants of John Summers, Esq. and Anna Van Deren who lived in Oxford, Sussex (later Warren), New Jersey. John and Anna Summers had five sons, three of whom died by 1832. However, family groups from all five sons migrated to Michigan in the early 1830s, constituting over 30 direct descendants, over half of whom were of adult age and who brought with them their spouses and their children. They settled near the county line of Oakland (Avon and Oakland twps.) and Macomb (Sterling and Shelby twps.) counties. After studying these families for several years, this report reflects my current and best deductions about which children belonged to which Summers brother. Most, but not all sources are listed in the End Notes. Corrections will be made as more information becomes available.

Note that John Summers, Esq. had a sister, Maria Magdalena Summers, who married Ernest Mann. Several Mann families descended from this couple also migrated to Michigan at the same time, and their information is included in a different report, "Descendants of Ernest Mann and Mary Summers."

1. **JOHANNES "JOHN"¹ SUMMERS ESQ.** was the youngest child of GEORG SOMMER (1722-1785) and ANNA BARBARA RUB (1723-unk.). Both parents were from Freistett, Baden, Germany, and they emigrated to Philadelphia in 1752 aboard the ship Brothers. John was born on 11 Mar 1759 in Germantown, Philadelphia, Pennsylvania. He died in 1827 in Warren County, New Jersey. He married ANNA VAN DEREN, daughter of David Van Deren and Magdalena Helena (Van Deren) in 1782. She was born about 1761. She died in 1821.

4. iii. **JOHANNES "JOHN" SUMMERS JR** was born on 16 May 1784 in Sussex County, New Jersey. He died on 15 Dec 1843 in Macomb County, Michigan. He married JANE GARDNER, daughter of James Gardner and Elizabeth Froome on 11 Oct 1807 in Sussex, New Jersey. She was born on 09 Jan 1783 in Sussex, New Jersey. She died on 01 Sep 1864 in Utica, Macomb, Michigan.

5. iv. **JACOB SUMMERS** was born on 07 Jan 1787 in New Jersey. He died on 25 Jul 1864 in Michigan (some sources say 1863 is the death year; burial Mt Avon Cemetery, Rochester, MI). He married (1) MARY HILES on 10 Mar 1811 in Sussex, New Jersey. She was born about 1789 in Pennsylvania (from daughter Margaret's death certificate). She died in Sep 1831 in Michigan (date not confirmed; burial Mt. Avon Cemetery, Rochester, MI). He married (2) MARY "POLLY" DECKER on 13 Apr 1841. She was born in 1794 in New Jersey. She died on 01 May 1873 in Oakland, Oakland, Michigan. He married (3) CHARLOTTE BRONSON. She was born on 03 Dec 1801 in New York. She died on 09 Sep 1864 in Michigan (burial Mt Avon Cemetery, Rochester, MI).
6. v. **WILLIAM SUMMERS** was born in Sussex County, New Jersey. He died on 19 Jul 1832 in Oxford, New Jersey. He married RACHEL HOAGLAND, daughter of Amos Hoagland and Ruth Carpenter on 18 Dec 1806 in Sussex, Sussex, New Jersey. She was born on 28 May 1786 in Sussex, Sussex, New Jersey. She died on 16 Feb 1875 in Michigan (burial Mt Vernon Cemetery, Macomb, MI).

2. **GEORGE² SUMMERS** (Johannes "John"¹ Esq.) was born on 02 Jan 1781 in New Jersey. He died on 01 Oct 1814 in Oxford, Sussex, New Jersey. He married SARAH HOAGLAND, daughter of Amos Hoagland and Ruth Carpenter on 01 Nov 1801 in Sussex, New Jersey. She was born on 30 Oct 1780 in Sussex, Sussex, New Jersey.

Notes:

- ♦ According to one source, there was one set of twins among these children of George Summers and Sarah Hoagland, but we don't know which two they were.
- ♦ Sarah Hoagland remarried to John B. Innis in 1818. She had one additional child (Ruth H Innis) before John died in 1824. What became of Sarah or her remaining children is unknown at this time.

3. **DAVID² SUMMERS** (Johannes "John"¹ Esq.) was born in 1782 in Sussex, New Jersey. He died about Sep 1825 in Warren, New Jersey. He married MARY "POLLY" HORN on 25 Dec 1806 in Sussex, New Jersey (the marriage certificate was written 1806, but then it was recorded as 1807; believe correct date was 1806.). She was born about 1785 in Sussex, New Jersey. She died on 06 Jul 1864 in Avon, Oakland, Michigan (burial Rochester Cemetery).

- iii. CHARLES SUMMERS was born in 1810 in New Jersey. He died on 04 Mar 1880 in Goodison, Oakland, Michigan. He married (1) LAURA TOWER, daughter of Cornelius Tower and Abigail Potter on 04 Aug 1839 in Oakland County, Michigan, USA. She was born on 08 Jun 1810 in Paris, Oneida, New York. She died on 21 Oct 1899 in Marathon, Lapeer, Michigan.
- iv. SARAH H SUMMERS was born on 18 Dec 1811 in New Jersey (calculated from age on her gravestone). She died on 13 Apr 1872 in Rochester, Michigan. She married LYMAN J WILLCOX. He was born in 1802 in New York. He died on 31 Jul 1885 in Rochester, Michigan.
- v. DAVID SUMMERS was born on 12 Mar 1817 in New Jersey. He died on 30 Mar 1891 in Detroit, Michigan (burial Rochester Cemetery; Martha appears in the 1891 city directory of Detroit as a widow of David.). He married MARTHA CLEVELAND PIPER, daughter of Charles L Piper and Lucy Caldwell on 14 Dec 1846 in Michigan. She was born on 10 Mar 1827 in Barre, Massachusetts. She died on 14 Jan 1908 in Detroit, Michigan.
- vi. ALFRED SUMMERS was born on 06 Mar 1818 in New Jersey. He died on 18 Jun 1885 in Brandon, Oakland, Michigan. He married SARAH MARIAH SHADBOLT on 19 Dec 1839 in Brandon, Oakland, Michigan, USA. She was born on 11 Nov 1822 in New York, USA. She died on 29 Jul 1910 in Getatown, Tuscola, Michigan, USA.
- vii. JARED SUMMERS was born on 12 May 1819 in New Jersey. He died on 16 Oct 1902 in Oxford, Oakland, Michigan (burial Oakwood Cemetery). He married AMANDA CALDWELL on 07 Aug 1845 in Lapeer, Michigan, USA. She was born about 1824 in Massachusetts. She died on 20 Sep 1895 in Thomas Station, Michigan.

He married ISABELL WELLS. She was born on 29 Jan 1816 in New York. She died on 23 Jul 1892 in Macomb County, Michigan (burial Utica Cemetery; per findagrave).
- iii. **JAMES GARDNER SUMMERS** was born on 06 Oct 1813 in New Jersey (date per gravestone). He died on 05 Mar 1891 in Shelby, Macomb, Michigan. He married ELIZA ANN AXFORD, daughter of Samuel Axford and Rachel Morgan on 14 Feb 1846 in Macomb, Michigan. She was born on 23 Mar 1821 in Canada. She died on 20 Jul 1873 in Utica, Macomb, Michigan.
- iv. **THOMAS JEFFERSON SUMMERS** was born in 1814 in Sussex, New Jersey. He died on 04 Jan 1881 in Macomb, Michigan. He married (1) ABIGAIL ST JOHN on 27 Jan 1842 in Oakland County, Michigan. She was born about 1822. She died on 02 Jul 1844 in Michigan (burial Utica Cemetery). He married (2) JULIA ANN BROWN, daughter of George Brown and Elizabeth Payne on 02 Oct 1845 in Oakland, Michigan. She was born in Aug 1821 in Michigan. She died on 25 Sep 1908 in Shelby, Macomb, Michigan.
- v. **MELINDA SUMMERS** was born about 1816 in New Jersey. She died on 09 Sep 1878 in Utica, Macomb, Michigan. She married JAMES B ST JOHN on 21 Feb 1839 in Macomb County, Michigan. He was born about 1810 in New York. He died on 22 Mar 1877 in Macomb County, Michigan (per gravestone).
- vi. **MARSHALL SUMMERS** was born on 03 Nov 1818 in New Jersey. He died on 23 Jul 1897 in Shelby, Macomb, Michigan (burial Utica Cemetery). He married CAROLINE A SHERWOOD, daughter of Jacob Sherwood and Phoebe Price on 28 Dec 1848 in Michigan. She was born about 1824 in New York. She died on 05 Aug 1908 in Utica, Macomb, Michigan (burial Utica Cemetery; informant was A.E. Millett of Armada, MI - who was that?).
- vii. **WILLIAM SUMMERS** was born in 1822 in New Jersey. He died on 24 Jul

1887 in Shelby, Macomb, Michigan. He married SARAH E (SUMMERS). She was born on 25 Sep 1822 in New York. She died on 25 Oct 1915 in Alma, Gratiot, Michigan (burial Utica Cemetery; see death certificate).

- viii. MARIA SUMMERS was born about 1823 in New Jersey. She died on 06 Jan 1847 in Macomb County, Michigan, USA. She married FRANCIS R CHAPEL on 16 Jan 1845 in Macomb, Michigan. He was born about 1818.
- ix. ELLEN SUMMERS was born about 1826 in New Jersey. She died on 05 Oct 1898 in Michigan (see death certificate link). She married WILLIAM W ANDRUS on 01 Feb 1849 in Macomb, Michigan. He was born in Jul 1821 in New York. He died in 1910 in Utica, Michigan (burial Utica Cemetery; needs to be confirmed).

5. **JACOB² SUMMERS** (Johannes "John"¹ Esq.) was born on 07 Jan 1787 in New Jersey. He died on 25 Jul 1864 in Michigan (some sources say 1863 is the death year; burial Mt Avon Cemetery, Rochester, MI). He married (1) MARY HILES on 10 Mar 1811 in Sussex, New Jersey. She was born about 1789 in Pennsylvania (from daughter Margaret's death certificate). She died in Sep 1831 in Michigan (date not confirmed; burial Mt. Avon Cemetery, Rochester, MI). He married (2) MARY "POLLY" DECKER on 13 Apr 1841. She was born in 1794 in New Jersey. She died on 01 May 1873 in Oakland, Oakland, Michigan. He married (3) CHARLOTTE BRONSON. She was born on 03 Dec 1801 in New York. She died on 09 Sep 1864 in Michigan (burial Mt Avon Cemetery, Rochester, MI).

He died on 06 Aug 1839 in Mount Vernon, Macomb, Michigan. She married (2) WILLIAM HENRY BEACH on 28 Jan 1851 in Coldwater, Branch, Michigan. iBaptism records from the St. James "Straw" Lutheran Church in Greenwich, New Jersey exist for two sons of John Summers Esq. and Anna Van Deren: George and John Jr. John Summers Esq. apparently died intestate, and no will has been found for him which might have named his family members. However, the following New Jersey court cases name John Summers Esq. together with four other Summers named David, William, John Jr., and Jacob, although no relationship was ever stated until the last case, which went before the New Jersey Supreme Court:

- ♦ The proximity of individuals one to another in Michigan.
- ♦ Deed transactions between individuals.
